The University of Colorado Boulder is seeking schools containing grades 6-8 or 7-9 in select states to implement the <u>Botvin *LifeSkills Training* (LST) Middle School program</u>. This grant provides everything you need to enhance your students' self-management, social, and refusal skills through a proven curriculum—all at no cost to your district.

#### What is the LST Middle School Program?

The Botvin *LifeSkills Training* Middle School Program is a comprehensive, evidence-based curriculum designed to promote healthy behaviors in students by building personal self-management skills, social skills, and refusal skills to prevent drug use, violence, and other risky behaviors.

#### Program Highlights

- Length of Lessons: Each lesson is designed to be approximately 45-minutes.
- Grade Levels: The program is implemented across three grade levels: Grades 6 through 8 or 7 through 9.
- Total Sessions: The curriculum includes a total of 30 sessions:
  - Grade 6/7: 15 core sessions
  - Grade 7/8: 10 booster sessions
  - Grade 8/9: 5 booster sessions

#### What Does the Grant Provide?

This grant covers the full cost of the following:

- **Curriculum Materials:** Three years of LST materials, including student guides and teacher manuals.
- **Teacher Training:** Workshops for all educators who will deliver the program. Teacher stipends of <u>\$200 per 6-hour training day</u> will be paid for LST workshops held during non-contracted time, and reimbursements will be paid to districts utilizing substitute teachers for LST workshops held during the school year.
- **Ongoing Support:** Access to technical assistance and capacity-building workshops to help sustain and finance the program long-term.
- **Teacher Appreciation:** <u>\$100 gift card</u> to LST teachers after implementation and survey completion.
- Site Coordinator Appreciation: Up to \$100 gift card for LST site coordination, dependent on size of site.

- **District Support:** Ensure your district and school(s) are committed to implementing LST as outlined.
- **Program Coordination:** Assign a Site Coordinator and Co-Coordinator to manage implementation.
- **Participation in Feasibility Meeting:** Attend a 60-90 minute meeting for an overview of LST and evaluation components and discuss implementation plans.
